All employees receive regular training on our Business Code of Conduct and all aspects of our policies and specific training modules for material aspects of Human Rights.

Due diligence and Risk assessment

At least every five years, ETEM GESTAMP ALYUMINIUM EXTRUSIONS S.A. performs a Human Rights Risk Assessment and due diligence process to identify and monitor actual and potential risks within the context of our operations and beyond.

Grievance and remediation

Internal grievance mechanisms and public <u>integrity hotline</u>, are in place to ensure that employees and all stakeholders can report concerns or suspected violations.

Supply Chain
